RESPONSIBILITIES - SAMPLE

Agrees to provide or continue to provide support and/or services in accordance with requirements and/or mandates of agency they represent. (ex: APS, BOH)

Agrees to serve as team leader, responsible for facilitating team communication, monitoring team progress, and providing team members with progress reports. (ex: Case Manager, Resident Service Coordinator, Social Worker)

Agrees to provide clinical support (mental health assessment, intervention, and support) to the resident throughout the term of the Collaborative Agreement (therapist)

Agrees to serve as team leader and provide clinical/mh support: responsible for team communication, monitoring team progress, providing team with progress reports. (ex: Clinical Social Worker)

Agrees to perform inspections on a regularly scheduled basis accompanied by an additional team member. (Inspection agency responsible for outside pressure.)

Agrees to perform inspections with another team member and provide information and feedback to team when necessary regarding deficiencies being rectified. (Inspection agency responsible for outside pressure or agency such as BOH.)

Agrees to provide information and feedback to team when necessary regarding specific inspection deficiencies that the team is working to rectify. (typically not primary inspector, ex: Property Mngmt, BOH)

Agrees to assist by addressing sorting, organization, and maintenance of goal target areas. (ex: family, organizer, housekeeping)

Agrees to address harm reduction targets listed, assist in removal of items from home, clean cleared areas as necessary, any heavy chore tasks that emerge. (ex: organizer, heavy chore svc.)

Agrees to provide therapeutic support, counseling, skills and strategies training (ex: hoarding specific therapist)

Agrees to be present, allow team members in for scheduled visits, participate fully, work with team in mutual effort to reach goals, work to maintain progress. (Resident)
